Minutes of the Winsham Parish Council meeting held in the Jubilee Hall on Friday, 13th September 1985 at 8.00 p.m.

47. Minutes.

The minutes of the meeting held on 9th August 1985 were signed as a true record.

48. Matters arising.

- Cemetery Gatepost. A letter from P H Hardwill was read, promising to replace the faulty gatepost shortly. Ref: Min: 34  
- The Wyatt Grave. No reply has been received from Mrs Barclay. A letter is to be sent asking for a reply.  
Emergency Planning - Mr Woodward said the Emergency Planning Committee had met and had been in contact with other groups locally. The next session of meetings by the County Emergency Planning Officer starts shortly. A new Alarm System is to be installed in the Post Office and the Emergency Telephone Numbers are to be updated.

No.32 Western Way, Winsham - Mr Fisher read a letter from the Housing Dept: asking the Tenant if he intended to keep the tenancy of the property. The letter also mentioned No.17 in a similar vein. War Memorial Nuisance - It was stated the nuisance is as bad as ever.

The Police are to be contacted again, asking for action to resolve the matter once and for all; Mr Slade said he would repair the hole in the Children's Recreation Ground wall when he erected the new Play Equipment.

Tree in Davies Close - Mr Fisher has contacted the Amenities Dept: re: pruning the Tree, he asked for the subject to be included on the November Agenda.
