Minutes of a meeting of Winsham Parish Council held in the Jubilee Hall on Friday, October 3rd, 1980

In the absence of the Chairman and the Vice Chairman it was proposed and agreed that Major K.I.Cameron should take the Chair as acting chairman for the meeting.

799 The Minutes of the last meeting held on Friday, August 29th 1980, having been circulated were signed as correct.

800 Matters arising

- 1) Ref. 790 (1). The Church clock. It was unanimously agreed to accept the quotation of £350, excluding V.A.T., given by Ray Ingram of Bridgwater for the repair of the clock. Mr Meech agreed to write to Mr Ingram accepting the estimate.
- 2) The Clerk had received a copy of a letter from the County Planning Officer written to Yeovil District Council concerning Public Bridleway 30/6 on Lue Farm. It asked for consent by Yeovil District Council for a cattle grid and for the provision of a bridlegate.
- 3) Ref. 792. Mr Colin Slade said that he had made two new swing seats and that he hoped to fix them during the coming weekend.
- 4) Ref. 795. The Clerk had written to our insurance company and had been told that we were already covered for public liability for £250,000.
- 5) Ref 797 (3). Levelling of graves in the cemetery. It was agreed that a survey would be requiredbefore any action could be taken.
