Mrs Loaring said it would be preferable to wait to see if any Grant would be forthcoming from the District Council. Some Councils had not taken up Grants allowed and there is a possibility that some money may be available. In the meantime Mr Fowler will obtain prices of wood chippings.

The Public Local Inquiry will be held on Tuesday, 26th January 1993 at 10 a.m. in the Function Room of the George Hotel, Fore Street, Chard. It was decided that the written submission sent on the 4th March 1992 is sufficient, as this will carry as much weight with the Inspector as evidence presented in person.

#### 72. Mr C Baigent.

In answer to Mr Slade's question on the maintenance of Council Houses, Mr Baigent said the remainder of Council Houses, apart from Davies Close, are due to be painted. Also new doors and windows are programmed. Faults on the new doors and windows in Davies Close are being attended to. On being asked, the Clerk stated that despite writing twice to Mr Keith Lockwood, the District Council Contract Manager, nothing had been done concerning the complaints.

Mrs Loaring asked what was being done about the Gate Post at the entrance to the Large Recreation Ground, this having been knocked down by a South Somerset Contractors lorrywhen men were working at No.10 Bakersfield. Mr Baigent will pursue this.

## 73. Mr J Trickett.

Mr Slade raised the subject of road flooding on the top of Crewkerne Hill and loose stones and earth on the road adjacent to the entrance to Midnell Farm.
