P.C. Olds reported. He said the Chard Station is still short staffed, down to 5 at the present. For the next two weeks he will be on duty at the Pilton Rock Festival.

16. Rules of the Cemetery.

Regarding Mr R Perrott's query. It was decided to ask for details, such as an illustration of the proposed headstone and kerb. The Clerk had received an enquiry regarding the Sawyer graves. One plinth and three headstones are requested. Again the Clerk was asked to obtain details. Mrs Rose raised the question of how few grave spaces are left in the Cemetery. This will be investigated and a survey made of possible re-internments.

17. Letter from Mr G Peacock.

Mr Slade asked for comments from the meeting. Mr Wilson considered the letter was not the complete story. Did not think the letter was worth discussing. Mr Smart said it was just another ploy for more housing; it should be opposed as before. Mr Woodward said he had doubts about what was intended. Mrs Fowler said some concrete decision should be made. Mrs Jones said the proposals would be of no advantage to the Village. Mrs Rose said the proposals are outside the development limit.
