The Financial Statement, previosly circulated, was agreed.

44. Mr C Baigent.

Mr Baigent raised the subject of Safety Surfaces. He said he was fairly certain the District Council will provide a Grant. The programme is, the District Council place the order for the Tiles etc and the installation, they settle the Account and the Parish Council pay the District Council next Financial Year, less any Grant.

It is calculated that the Tiles, Adhesive and Carriage will cost £1333.00, the Installation will cost £853.00. If a Grant of 75% is made the Parish Council will have to pay £546.50p.

It was proposed by Mrs Rose and seconded by Mr Wilson that the order should be placed. The proposal was carried. The Clerk will contact the Leisure & Arts Dept. and arrange the Order.

Mr Trickett said one cut per year was programmed for road verges. This is for safety rather than tidiness.

Regarding the A30 Chard - Crewkerne Road. Double white lines are being discussed but this road is 14th in priority.

46. Street Lighting.

Mrs Rose said she does not accept the decision made at the Parish Meeting on the 25th September. She maintains that many people did not Know a meeting had been called. Mrs Loaring said posters had been displayed. Mr Wilson queried the legality of the number at the meeting being a quorum. Mr Speyer considers the decision of the meeting should stand. The legality of the meeting will be investigated and the subject will be on the Agenda of the next meeting.

Mrs Loaring and the Clerk have checked the Cemetery Plan and noted old graves where re-burial is legal. These have been marked on the Plan.

48. Old Lamp opposite Court Street.

The iron lamp container is with Mr Slade at present. The Clerk will contact Mr Slade regarding necessary repairs. If Mr Slade would rather not do the work, the Clerk will contact Mr John Gibbons asking him to do the repairs and submit his Account. It will be necessary to obtain part of a telegraph pole on which to mount the ironwork.
