84. Grass Cutting.

The Clerk was asked to obtain Tenders for cutting the grass for which the Parish Council is responsible. It was agreed to ask the following contractors. Mr A M Smith, Mr Andrew Partridge, B Powell & Sons and Shearings. The requirements will be: - 9 cuts at 3 weekly intervals, Paths to be swept of grass cuttings, all edges and around play equipment supports to be strimmed, the grass to be cut short and to a level acceptable to the Parish Council. The usual areas of grass will be stated. If extra cuts are required, this will be at the discretion of the Parish Council and would be paid at the rate of the 9 cuts. This Council will not necessarily accept the lowest Tender.
