81. Finance.

Mrs Loaring said the Parish Precept had been increased to £8500. This is to enable the Street Lighting Account to be paid. See next item.

82. Street Lighting.

It has been found that the Quotation from SWEB holds good for 6 Months. £4855 has to be forwarded with the Order, leaving a balance of £3639. The Order will be sent when the Precept is to hand. \cap

8 minutes picking up a few bits of rubbish and then left. Mrs Loaring said if the District Council would provide the necessary equipment, she and the Clerk would do the scavenging once a Month. Other Councillors said they would help. Mr Baigent will make enquiries regarding this suggestion.

Mr Woodward reported that the County Council Mechanical Road Sweeper and two men with brushes were in the Village on the 14th January.

Mr Speyer proposed, seconded by Mr Fowler, that the stones of the fallen wall should be removed and replaced with posts and rails. It was thought that perhaps Mr Slade would accept the stone for the posts and rails. Cars have used the Cemetery Path and because of the unusually wet weather, have left wheel tracks.

The Cemetery Hedge needs serious pruning. The Clerk will cut a section of the hedge to the required amount and then obtain prices to cut the rest to the same amount.
