PLAQUE FOR OLD LAMP POST. The Clerk has found out that the lamp was an oil lamp. He will get prices for the Plaque in Plastic and Metal. The inscription will read 'Oil Street Lamp - Circa 1900'.

Mrs Loaring said double white lines were necessary on the A30 between the Windwhistle Inn and the Filling Station because of the danger of speeding traffic and the junctions to Chillington and Purtington. Also the exit from Cricket St Thomas at London Lodge.

The subject of Traffic Calming at Forton was raised and itwas generally considered the project to be of very poor standard. The signing is poor and it is also understood that Traffic Calming cannot be carried out when

there is no street lighting.
