### 12. Minutes.

The Minutes of the meeting on the 8th May 1992 were signed as a true record.

The Chairman then adjourned the meeting for a talk by Mr Whitmarsh on Traffic Calming.

Mr Whitmarsh suggested a visit to Stiby Road, Yeovil would be useful to see the scheme which had been carried out. Certain schemes can delay the emergency services but both the Police and Fire Brigade favour 'Humps' in the roads.

The County Council in conjunction with the District Council will prepare a scheme and costings. The County Council will provide 1/3 of the cost. 'Rumble Strips' are not favoured because of the noise factor. Mr Whitmarsh then left. This subject will be on the next Agenda. The meeting was then reconvened.

## 13. Matters arising.

STREET LIGHTING. Mr Speyer reported. 20 sites have been located, the lights being fixed on SWEB poles. If BT poles can be used, a further 2 or 3 lights can be fixed in Western Way. The cost to the Parish Council would be approx. £1300. The Clerk will ask the Street Lighting Officer of the County Council to meet with Parish Councillors to discuss the proposed scheme and obtain a price.

NOTICE BOARD. With the help of the Clerk, Mr Weller will fix the new Parish Council Notice Board for  $\pounds 5$ . This was agreed.

SAFETY SURFACES FOR SWINGS. The Clerk was asked to chase catalogues and prices.

The Clerk was asked to contact Mr P Pym for anaccount for fixing the new Footpath Marker Posts.

The Shunter in the Small Recreation Ground has been removed. Mr Slade considers the metal left in the grass is dangerous. He will fill the holes with clay on Monday.

Police - re: the Break-in. The Clerk was asked to send copies of all correspondence on this subject to the Chief Constable, Mr D Shattock at the Bristol H.Q.

On the 28th May 1992 a meeting was held on the subject of the Future of Local Government. The talk was given by Miss Helen Rutter - Policy Co-ordinator, Mrs Jane Clark - Leader of the District Council and Mr Andrew Grant - Area Co-ordinator/Housing.

The District Council are responsible for Housing - 10,500 units, Planning, Economic Development and Tourism, Refuse Collection - 90,000 Refuse Bags collected each week, Recreation and Arts, Countryside, Highways, Sewerage, Local Tax Collection and Benifits, Licensing and Land Charges, Environmental Health and Car Parks.

The population of the District is 143,300.

In 1991 over 3000 Planning Applications were dealt with and most were settled within the 8 week period.
