STREET LIGHTS. All the Lights in Western Way are now connected. The missing Light in Bakersfield has been replaced. Paid for by the County Council.

The Light in Back Street will be installed within the next two weeks - again the extra cost borne by the County Council.

The County Lighting Engineer will be asked to visit the Village in the evening to advise on filling in 'Black Spots'.

NEIGHBOURHOOD WATCH. A scheme has been set up. A letter recivived from Mr Howell, the Co-ordinator, asking for a donation to buy Notices. £70 is required. Mr Wilson suggested the full £70, Mr Fowler suggested £20 and Mr Woodward suggested £25. On a vote £25 was decided
