# WINSHAM PARISH COUNCIL

Minutes of the meeting of Winsham Parish Council held in the Jubilee Hall on Friday, 13 January 1984 at 8.00 p.m.

#### 97. Apologies for Absence

An apology for absence was received from Mr E Bannen.

# 98. Minutes

The minutes of the last meeting, held on 9 December 1983, were signed as a correct record, having been circulated previously.

# 99. Matters Arising

Ref 96:- Mrs Loaring reported that rubbish was being collected from Colham House monthly.

# 100. Cemetery Path

The Clerk reported that contracts had been exchanged on 15 December 1983, Mr Hardwill had been notified that the fencing work was now required to be carried out. Discussion ensued regarding the state of the path and it was agreed to discuss this again when the fencing work had been carried out. It was thought that a voluntary working party could be formed to tidy the path.

#### 101. Play Equipment

The competition entries were shown to the meeting. Discussion took place with regard to finance for play equipment. It was agreed to make an appeal for an old tractor which could be immobilised and Mr Slade agreed to look into the possibility of providing a tyre on a rope.

# 102. Grass Cutting

It was agreed that there were three options open to the Council:- (a) use the District Council; (b) go out to tender; and (c) voluntary or a small fee to an interested person. Should (c) be agreed it would be necessary to purchase a mower and a strimmer. It was agreed that a notice should be put up asking for help and also circulate to the P.C.C. and village magazines.

#### 103. War Memorial

Mr Smart had spoken with a member of the Divisional Highways staff.who had visited the site. The County Council were prepared to make a minor alteration at no charge to the Council and it was agreed to accept their offer. Mr Slade agreed to repair the broken stone on the memorial. It was noted that at present there is no finance for any repair work, repointing, etc.

#### 104. Clerk's Appointment

Mr Harvie had accepted the post of Clerk following a meeting with the Chairman and Clerk. Mr Vincent withdrew his application on 11 January 1984.

Mrs Loaring proposed, and it was seconded by Mrs Fowler, that a sign should be erected in the children's recreation ground stating "No Cycling".
