Minutes of the Winsham Parish Council meeting on Friday, 13th September 1991 in the Jubilee Hall at 8.p.m.

36. Apologies for absence.

37. Minutes.

The Minutes of the meeting on the 12th July 1991 were signed as a true record.

38. Matters arising.

MAINTENANCE OF COUNCIL HOUSES. Nothing more heard about this. Mr C Baigent will contact Mr Froom at Chard.

TREES IN DAVIES CLOSE. The District Council have agreed to deal with this matter. Mr Baigent check on when.

Regarding dampness in the Sheltered Housing in Davies Close, steps are being taken to deal with this.

CAR PARK AT REAR OF WESTERN WAY. This matter has been passed to Mr Bates of the Housing Dept.

NO 13 WESTERN WAY. The District Council will finish the works and clear the Site during the next 2 or 3 months. A check will be kept on this. FENCE IN THE LARGE RECREATION GROUND. The District Council advise that this fence is the responsibility of the Parish Council. Mrs Loaring does not agree, saying the District Council erected the fence in the first place. Permission will be sought from the District Council to replace the gate leading to Davies Close with a staggered barrier. This may determine to whom the fence belongs. Also records will be checked in an effort to prove the ownership of the fence.

SURFACE DRESSING OF WYNYARDS LANE. Mr Trickett will contact the Highways Dept next Monday.

MANHOLE COVERS ON THE B3162. These have been replaced.

NO DOG SIGN FOR THE CEMETERY PATH. Mr Baigent took details and will deal with the request.

39. Police.

P.C. Mazzei reported. The Chard Station is up to strength at the moment, with 10 Officers. He agreed to visit the School and the Play School. Concerning cars speeding through the Village, he said there was very little could be done about this.

Mr Trickett suggested a publication entitled 'Traffic Calming' should be requested from County Hall.

Mrs Loaring she would like 'SLOW' signs to be painted on the road each side of the Cross Roads.

Mr Wilson said Policemen on foot would be benificial in villages. Post Code stamping on bicycles will be arranged at the School.

41. Mr C Baigent.

Mr Baigent reported to Mr Trickett that the corner of Ebben Lane and Crewkerne Hill is being torn up by heavy lorries going to farms. They were also damaging private drives. Mr Trickett will investigate.

42. Mr J Trickett.

Cricket St Thomas will erect a sign discouraging lorries from driving through Whatley.

Regarding the requested sign at Kingstonwell Lane. This has been refused. Mr Trickett took details and will pursue the matter.
On Traffic Calming. Mr Whitmarsh is prepared to visit the Village to discuss this matter if requested.

43. Street Cleaning.

The District Council took over this service from the County Council last April, and are programmed to carry out the work 3 times per year. The scheduled 19Km is thought to be ridicuous, taking in Cow Down Road, Whatley Lane and other narrow lanes. Mr Baigent has a copy of the schedule and will contact the appropriate Dept to sort out the matter. The service is not being carried out satisfactorily.

44. 'Know your Village' Trail.

This event will take place on Sunday, 15th September, starting at 4.30 p.m. from the Recreation Ground, Bakers Field. It is a Fun Walk and replaces the usual Winsham Wander.

45. Play Equipment.

Mr B Speyer said the ground is worn away under the swings to such an extent that smaller children cannot reach the swing seats. He suggested that the ground should be made up and safety matting installed. He was told the mats are very expensive and the Parish Council could not afford the cost. The Play Equipment Inspector states that new bumpers and a new plank are required on the See Saw. New bumpers are in hand but a special key is needed to fix them. Mr Slade will inspect the plank and if necessary, will get a new plank.

Mr Baigent considers a barrier at the exit from the path by the War Memorial would stop children running into the road. This will be on the next Agenda.

46. Shell 'Better Britain' Campaign.

Ideas were requested and will be discussed at the next meeting.

47. Lamp Post in Church Street.

It was agreed that the ironwork should be repaired. Mr Slade will obtain a new post and the whole post will be replaced in its original position.

48. Financial Statement - Receipts and Payments.

The Clerk had prepared a Financial Statement to 31st August 1991 which was handed to the meeting. Mr Wilson asked for subsequent Statements to be photocopied and handed to Councillors 2 or 3 days before the meeting.
