65. Minutes.

The Minutes of the Meeting on the 12th November 1993 were signed as a true record.

66. Matters arising.

Street Lighting. Regarding Mr Thistletwaite's visit to advise on filling in 'black spots', Mrs Loaring wished to know why this is important at this particular time. Mr Slade said he had raised the matter for future consideration.

The Light in Back Street is not complete. The Clerk was asked to chase the matter with SWEB.

When this Light is fixed, Mr Thistletwaite will be contacted regarding his visit.

Notice in Small Recreation Ground. Mr Fowler said this will be fixed soon. Recycling Payments. The first and only payment made by the District Council was in March 1993. It was decided to wait until March 1994 before pursuing the matter.

67. Police.

There has been damage done to the Back Street road sign on the corner of High Street.

It was stated that the Police do not attend incidents when asked. The Clerk was asked to write to Superintendant Norton at Tauntonwith a copy to Sgt. Swatton at Chard. The letter will read something like - 'We understand that two incidents have been reported to the Police but no attendance was made. We feel that an attendance, shortly after the event, would be supportive to the people concerned. This Council would be interested to know if this system of non attendance will continue.'

Mrs Rose asked for a large pot-hole on Crewkerne Hill to be filled.

72. Cemetery.

Mr Speyer said there had been 19 burials in the last 3 years and there were about 8 grave spaces left. He did not agree with reburial. He said 'Would it be possible to purchase some land on the Ammerham side of the Cemetery to extend the burial spaces'. He suggested a Committee be formed to investigate the matter. This was agreed and the Committee is Mr Speyer, Mrs Gowers and Mrs Rose will assist after Easter. The Clerk offered his services.
