95. Police.

P.C Andy Mazzei spoke first. He apologised for not attending recent meetings. He expects to be able to carry out Cycle Coding next Tuesday,

He will advise Mrs Loaring.

Sergeant Roger Blandthorne then spoke on the subject of the Policy of Caution. Offenders are spoken to, cautioned then asked to sign a Form admitting guilt. This is recorded and if the persons commit another crime they will be prosecuted. The Policy of Caution or prosecution is decided by the Custody Sergeant on duty at the time of the arrest.

Mr Wilson and Mr Speyer both consider the recent case of burglary in the Parish of Winsham to be serious enough to warrent prosecution and the cautioning of the offenders was far too lenient.

Mr Wilson proposed, seconded by Mr Speyer that a letter stating the

dissatisfaction of the decision regarding the recent crime should be sent to the Police H Q at Yeovil. The proposal was carried.
