90. Apologies for absence,

91. Minutes.

The Minutes of the meeting on 11th January 1991 were signed as a true record.

92. Matters arising.

Mr Cox, Highways Dept, called upon the Clerk regarding the rubbish in Back Street and the Road Signs. These works have now been completed. Wessex Water have repaired the leaks reported after the last meeting.

94. Planning.

901251 Mr G Peacock. Consultations still in progress.

903291 Mr B J Taylor. No objections by this Council.

903290 Mr M J Scott. It is considered the proposed extension is too large.

901567 R J Pike & Sons. The use of land at the rear of Victory Garage as a Contractors Yard.

An Appeal has been lodged against the refusal of this Application.

It was decided to reiterate the previous comments of this Council.

902948 Mr W J D Taylor, Cricket St Thomas. Estate Managers House.

Following the opposition of the Application, Mr Taylor has 'phoned Mrs Loaring on the subject. It was decided to write to Mr Taylor stating that it is understood he is considering a full

planning application but without any new proposals this Council cannot reconsider the previous comments.

910272 Mr M Hebditch, Street Farm. First floor extension. This is to be discussed.

95. Grass Cutting.

Two quotations received. From Mr A M Smith - Grass cutting £900 and Hedge cutting £300. From B E Powell & Sons - Grass cutting £1080 plus VAT and Hedge cutting £350 plus VAT. It was decided to accept the price from Mr A M Smith.

Under this heading the subject of Footpath CH 30/1 was raised. It was reported that an electric fence is across the path and also cattle are being fed close to the gate at the Ammerham Lane end. This will be brought to the attention of

the Footpaths Officer, 96. Annual Parish Meeting.

Mrs March has been visited by Miss J Cordy of the Environmental Health Dept. The Housing Dept have asked the Social Services to have their Psychiatric Social Worker visit Mr Peadon.
