956 Matters arising

- 1) Ref. 948. The Clerk reported that the residential caravan at Leigh House Farm would not be used after November this year.
- 2) Ref. 953. Overgrowth and untidyness in the Vicarage grounds. The Clerk was asked to write to the Diocesan Secretary concerning this.

957 Planning

812191 An Appeal had been lodged by Mr R. Wheaton against Yeovil District Council decision to refuse permission for:-  
The erection of a bungalow and garage on land adjoining Church Farm, Church St., Winsham.

Winsham Parish Council were opposed to this application for the reasons originally given in our letter to Yeovil District Council on Dec. 2nd., 1981.

821088 Agricultural tying clause.  
The continued use of dwelling house at Oakleigh, Ammerham, Winsham, without the agricultural tying clause for Mr J.W.Jeffery.  
The Parish Council considered that this should not be lifted.

The following two applications had been made:-

821109 To convert buildings facing Fore St into a bungalow on Forge House property for Miss Muriel Churchill of Forge House, Fore St., Winsham.  
The Council considered that this new dwelling would be overlooked and would overlook Forge House. We also thought that a new dwelling adjoining a garage/workshop was unsuitable accommodation. Vehicular access for both the new bungalow and also for Forge House across the busy garage forecourt would be most unsatisfactory.

821265 The conversion of barn on land at Innisfree, Purtington, Winsham into a dwelling house for the prospective purchaser, Mr R.J.Brennan of Rojan, Weir Lane, Yeovilton, Somerset.  
The Parish Council considered that this application by the proposed purchaser of Mr Corr's land seemed to differ only slightly from No. 801666 submitted by Mr C. Corr which this Council recommended for refusal as being beyond the confines of the hamlet of Purtington. That application was refused by Yeovil District Council on Sept. 18, 1980, as being undesirable sporadic development etc, with substandard road access, and our Council again recommended refusal.

958 Cemetery Path


The Chairman said that he had written to Cluttons as agreed at the last meeting.
