1198 <u>RECREATION GROUND COMMITTEE/ SPORTS & SOCIAL CLUB</u>

District Councillor Mrs Stella Abbey reported: -

Maintenance is the major expense. The only income comes from the Football Club and the Sports and Social Club. We are struggling to pay each month's bills. The odd arrangements for paying bills is unnecessary. The Sports & Social Clubs lease ran out a couple of years ago, so the time is right to reorganise roles & responsibilities. The S&SC has done well recently on fund raising but money keeps going out. Some repairs are needed; we have the same problems as the Jubilee Hall but on a smaller scale. Our only option is to repair what we have; there are no funds for renewal. The end wall near the field needs urgent repair; we may ask the Parish Council for financial help with this repair.

On the plus side activities have greatly increased, football is going extremely well, two matches a week and a women's match. The bar is better organised. We are moving in the right direction.

1199 JUBILEE HALL

Councillor Mr Roger Beer reported:-

We have received a major grant for a PA system & hearing loop of £6000-00. The big grant funding is not available until November. There are three communities in the running for this type of grant, two for new build. Standing orders are trickling in but our fund raising sub committee still need to raise £5000-00 per annum, a tough challenge. We need to make a major decision on how the floor is to be constructed, sold or wood. Things are moving along.

Weekly Work Schedule' on an ongoing basis, (yes). Work to repair the road through Purtington will start on 19th September

The Chairman remarked that the standard of workmanship on road repairs has greatly improved. The standard is the highest I have seen for 20 years.

The following is a list of highway issues discussed with Tony; they will be reported to the help desk via email on RoadsandTransportSD@somerset.gov.uk:-

- 1. Colham Lane Winsham is getting narrower. The hedges extend outwards and obstruct the road signs.
- 2. A new problem is emerging, because of satellite navigation; traffic volume on narrow lanes is now on the increase. HGV's and other delivery vehicles turn off the A30 at Windwhistle, cutting down the 4 miles of narrow lanes into the village, they can not turn around. The Parish Council request a sign 'Road Unsuitable for HGV's' be erected near the junction with the A30 at Windwhistle.
- 3. Leigh Lane Winsham, the iron gulley lids are corroding. If a horse steps on a cover it could collapse, can you investigate?.

We have established where the route of the path should be and we will consult with the landowner with regards the installation of gates or stiles. Les will be arranging all the necessary work as soon as the crops have been taken off.
