PUBLIC FORUM

(a) <u>Questions from Residents</u>

A resident spoke about a possible future planning application for their son that will be shortly submitted and left information for the members to read.

Another resident queried the presentation the members received prior to the Parish Council meeting starting. The Chairman confirmed that no decisions of any kind were agreed and that a public meeting would be held for the residents to attend in due course.

Other members of the public had concerns about the grass cutting in the cemetery. A letter received from a resident was partly read out at the meeting. The Council confirmed that it was doing all it could to get the most value from the current contractor and that this was an ongoing process.

(b) District Councillor's Report

District Councillor Sue Osborne gave her report on events in the area over the last month, which included:

The Local Plan is progressing and an additional District meeting will be held in August in this regard.

A report about Business rates will be issued next week.

Possible funding for businesses in the Parish may be available under the Rural Development Programme - Winsham is part of the Blackdown Hills Grant.

Highways – The additional funding that has been made available is likely to be spent on the Somerset levels. An enquiry has been made to David Laws to see what funding will be available for highways in the area.

(c) County Councillor's Report

County Cllr Linda Vijeh's written reports for June and July have been sent to members. Cllr Chance asked if it was possible to claim some money from County to cover the Council's recent first aid courses, but this isn't possible. It is hoped that one additional session in every parish and a separate one for schools will be held in due course should the training be approved.
