PUBLIC FORUM

(a) Questions from Residents

One question received via ClIr S Abbey which was discussed under Items to Report.

(b) District Councillor's Report

District Councillor Sue Osborne gave her report on events in the area over the last month, which included:

- The resumed Local Plan hearing is next week, Tuesday to Friday with the main areas of concern being Ilminster and Yeovil. It is hoped the Local Plan will be finalised by the end of the year.
- The Mount Hindrance application appeal was last week, following which the Inspector will take a tour of the road system this week.
- Discretionary Rate Policy a consultation document will be issued towards the end of June for 6 weeks. The general public can complete a questionnaire online or by paper copy. A press release will be issued in this regard.

(c) County Councillor's Report

County Cllr Linda Vijeh's written report for May has been sent to members.

Item number 5 The Band Hut and Allotment Site was brought forward on the agenda as County Cllr Linda Yijeh couldn't stay for the whole meeting.

2703 THE BAND HUT AND ALLOTMENT SITE

Cllr J Chance confirmed that SSDC had refused to remove the additional restrictive clauses it had added to the draft contract since our agreement to purchase the site. He had therefore written to the portfolio holder Cllr Henry Hobhouse on 1 May, explaining the problem, and asking for his help in resolving the matter.

Cllr Hobhouse had not replied to our letter, despite Cllr Osborne attempting to follow the matter up on our behalf.

The view of the meeting remained that the terms currently being offered were unacceptable to the Parish, and it was clear that SSDC was no longer prepared to transfer the site to the Parish on the terms originally agreed, and resolved by the SSDC D Committee in July 2012: by default SSDC had terminated the negotiations.

Resolved: It was agreed that Cllr J Chance will

- 1. Write to Cllr Hobhouse expressing disappointment that SSDC is not prepared to honour the agreement, and asking what SSDC intend doing about the site now that the Parish will not be taking it over, particularly bearing in mind the potentially dangerous condition of the Band Hut.
- 2. Copy the latest correspondence to our solicitor for the file, and request a final invoice.
- 3. Contact the SSDC Deputy Director for Finance, explaining the situation and asking SSDC to compensate the Parish Council for its wasted legal costs.
