901 Matters arising

- 1) Ref. 890 (1). Nothing further had been heard from Mr Wilson, the Amenities Officer, about the Bridleway 30/6 on Lue Farm.
- 2) Ref. 890 (2). Cemetery Path. A meeting with Mr Wheaton took place on Nov. 20th. He said that he would not be putting any cattle into the field leading to the cemetery before May. He wanted each organization who had to use the path to have a separate padlock to the chain on the gate.
- 3) Ref. 890 (3). Mr C. Slade said that there was once again flooding in Broadenham Lane and the Clerk was asked to inform Mr Rosser. She was also asked to get a new sign put up in Back St. as there was no trace of the former street sign.
- 4) Ref. 890 (4). The Clerk was asked to write to SMP (Landscapes) Ltd for their catalogue and price list and to ask Mr Wilson for details and names of other firms supplying play equipment. It was thought that the provision of new equipment might be discussed at the next Annual Parish Meeting.
- 5) Ref. 898. A letter had been received from Mr Rosser saying that Mr E. Howe was putting in hand the scheme for the diversion of the down pipe from the side roof into another drainage system on his property.

The new building would be in a prominent position on first entering the village and it was outside the existing development area as shown in the Winsham Village Policy Map.

812246 The erection of a first floor extension to dwelling house at "Nyumba", Whatley, Nr Winsham for Mr and Mrs R. Moyle
The Council had no objection to the application

Outline. The erection of a bungalow on land at Court Farm, Winsham for Mr R.B. Wheaton.

The Council noted that planning permission for the same site to be developed was refused in 1978. "Because of the awkward shape and contours of the site the erection of a dwelling on this land, which has a very limited frontage onto the adjoining unclassified road, would result, in a development poorly related to exisiting and proposed development which could prove detrimental to the amenities currently enjoyed by existing and future householders and could make the

provision of satisfactory access arrangements difficult to achieve". The Council considered that tese reasons were still valid and thought that the site was unsuitable especially because of its poor access to the unclassified road. It was also outside the area proposed for residential development in the Winsham Village Policy Map.

905 Storm Damage in the Cemetery

The cemetery had suffered considerable damage in the recent blizzard. A large tree near Row J had been uprooted and had fallen across Rows J and I, bringing with it some of the cemetery railings. The Monkey Puzzle tree had suffered a lot of damage and its branches had been scattered throughout the cemetery. Mr Ashman had removed the tree and cleared up all the debris and the Council were very grateful to him. The Chairman had agreed to this offer of clearance by Mr Ashman and now sought the Council's approval which was given. It was understood that when there was no urgency such a matter would, of course, be referred to the Council in the first place.

- Any other business. A light was still wanted between Mrs facey's house and that of Mrs Akhurst in Bakersfield. The owners of Goosemoor were worried about flooding in Fore St. near their house.
