#### 836 Matters arising

- 1) Ref. 825 (1). Bridleway 30/6 on Lue Farm. No further development.
- 2) Ref. 825 (2). Levelling of graves. The survey was being made.
- 3) Ref. 830. Proposed single street lights. The Clerk had written to S.W.E.B. and asked them to instal a footway light near the George. She had also written to Yeovil District Council and asked if they could instal a light in Bakersfield for the two new Council bungalows there.

The Chairman had approached the Diocese about this and had spoken to Mr Swarfield who hoped that a reasonable solution to this problem could be found when the Vicarage and the land was sold. ## 839 Somerset Association of Local Councils

Mr Smart reported that at the last meeting there had been a talk on small industries in rural areas. There had been a discussion about the new Housing Act. It was now easier for District Councils to sell Council houses. The BBC had now dropped the proposal to erect a mast at Henstridge.

#### 840 Correspondence

County Council Elections. Notices of Elections for the County Electoral Divisions within the District Council's area had been displayed. The election would be in May and the last date for nomination of candidates was April 6th. It was much regretted that Commander D.V. Jesseman, our former County Councillor, had recently died.

Concessionary Fares Schemes. These were for senior citizens and the disabled and notices about the issue of tokens had been displayed.

Hazelwood Hill Cutting. Mr Rosser had written to say that he had obtained permission to erect warning signs for falling rocks at each end of the cutting to warn motorists of the possible hazard.

Somerset County Council. Various reports had been received from Somerset County Council including those of the following committees:-

Policy & Resources; Libraries, Museums & Records; Agriculture; Education & Cultural Services; Exmoor National Park; Planning & Transportation; Public Protection; Social Services.

#### 841 Any other business
