25. Matters arising.

ROAD SURFACES. Mrs Loaring asked for lists of road surfaces faults from the Councillors, with a view to fixing a meeting with Mr Roy of the Highways Department.
FOOTPATH MARKER POSTS. Mr Howers reported these have been installed. Mr Smart said 1 Post had been wrongly sited. Mr Howers said he would resite this and check the others.
CEMETERY GATE. This work was to have been done this week but had to be postponed due to an emergency job.
FENCE IN THE CHILDRENS RECREATION GROUND. The new fence is now installed.

881684 Kingsfield Tree Nursery. This application was discussed at length. Mr Smart said the proposed houses would be outside the Development Limit but this can be altered. Miss Cleave said her main concern was the increased traffic in Fore Street. Mrs Loaring said the Site is within the Conservation Area. The proposal made by Mr Wilson at the Public Meeting on 20th June was read. Mrs Loaring then asked if the Parish Council wished to make a decision on the Application or if it should be left to the Planning Committee. Miss Cleave proposed, seconded by Mr Howers that the findings should be forwarded by the Planning Committee. This was agreed. Mrs Loaring wished it to be put on record that Mr Peacock does a lot for the Village and for conservation.
