

## WINSHAM PARISH COUNCIL

Minutes of the Winsham Parish Council meeting on 9th January 1987 - Cont'd.

### 99. District Councillors Report.

Mr Fisher has complained at the lack of regard for notifiable deceases, especially in view of the present fear of AIDS.

### 100. Resignation of Councillor.

A letter was read from Mr E Bannen tendering his resignation from the Winsham Parish Council. As it is less than 6 months to the next election of Local Councillors, no replacement Councillor will be elected or co-opted.

### 101. Somerset County Playing Fields Association.

It was proposed by Mrs Fowler and seconded by Miss E Cleave that £5.00p. should be donated. This was carried unanimously.

### 102. Colham Lane

Mrs Loaring spoke on the muddy condition of the Lane and suggested this should be reported to the Highways Dept.

Several faults in road services in and around the Village were reported. They were - Davies Close, Bakers Field, by Midnell Farm, Outside the Chapel, and an Inspection Cover opposite Davies Close. Also the entrance and exit to the parking lot in Western Way. It was decided to contact the County Surveyor and ask for a meeting with the Trench Inspector, The suggestion was to have a "Hole in the road week".

### 103. Chard Local Plan.

The Parish Council's representations were read and it was announced that these will be submitted to the Enquiry Inspector.

The Development Limit at Colham Lane/Back Street was discussed. It is considered that the change in this area constitutes an addition to the Limit when the letter on the subject from District Planning states that no extension to the Limit will be made.

### 104. Jubilee Hall.

Mr Woodward reported that the Jubilee Hall Management Committee want to make improvements to the Hall and are considering some fund raising events as it is the Centenary Year. He wished to know if the Parish Council would be supportive of any events.

It was decided the Parish Council would arrange a General Open Meeting in an effort to enlist the aid of Local Organisations.
