47. Apologies for absence.

Miss E Cleave, Mr D Wood ward and Mr D Howers who has sent a letter of resignation. The letter will be acknowledged.

48. Minutes.

Ref: Min: 40 - Planning No. 882213. The name Dobbs should read Hobbs. After the alteration, the Minutes of the meeting on 12th August 1988 were signed as a true record.

49. Matters arising.

ROAD SURFACES. The Councillors were asked to provide the Clerk with written details of poor surfaces.

FOOTPATH MARKER POSTS. The Clerk was asked to contact Mr Howers and ask him to deliver any unsited Posts to Mr Smart at Hazelwood Farm.

STREET NAMEPLATES. Mr Fisher has seen Mr Hughes and asked for a meeting in Winsham to discuss this matter.

SPEED LIMIT. The enforcement order date has not been reached. It was agreed to mention the poor siting of the Limit Signs to Mr Roy when he visits Winsham regarding road surfaces.

STREET LIGHTS - BURNING HOURS. After further discussion, it was decided to reverse the decision as per Minute No. 45 and ask for the lights to burn all night.

52. Mrs M Montagnon.

Regarding the Weight Limit, Mrs Loaring read a letter from the County Council suggesting that the Street signs may be changed in an effort

to dissuade heavy transport from using the B3162. Mr Smart said a letter should be sent to the County Council asking if there is a co-ordinated policy on signposting with the Dorset County Council.

52. Mrs M Montagnon. Following a request from Mrs Loaring, the Road Sweeper spent the day in Winsham.

On enquiring about the local bus service, Mrs Montagnon was told the service is quite satisfactory.

53. Mr L Fisher.

Mr Fisher raised the question of the Winsham Sewerage Plant at a District Public Health Meeting. A Site meeting will be arranged. Mr. Fisher was told of an unsatisfactory letting of Council Houses in the Village. He said this had all been decided without his knowledge.

54. Jubilee Hall.

Mr Smart said there is a hitch in the VAT Claim but this is being pursued. The controversy of the rear access to the Hall will be followed up.

Mrs Loaring asked the Councillors to give this matter serious thought and try to come up with some ideas at the next meeting.

Winsharn Wander 9 was fixed for Sunday, 25th September 1988. The usual Committee will meet to fix a route.
