Monumental Masons assure the Clerk that the work is in hand. Mr Burgess has applied to have a headstone erected on the grave of the late Mrs Dowell and for the inscription to be re-worked on the headstone

of the Evans grave. Further details will be sought and the Chairman will decide on what is allowed.
