Minutes of the Winsham Annual Parish Council meeting held on Friday, 12th May 1989 at 8.00 p.m. in the Jubilee Hall.

DOGS FOULING. Mrs Loaring, Mr Wilson and the Clerk met the Dog Warden in
Winsham. The Warden's suggestion was that the Children's
Recreation Ground should be fenced or partly fenced. He also
said the grass should be kept short. The signs as ordered
will be supplied free of charge.

CEMETERY HEDGE. The Clerk had 'phoned Mrs McCallum, asking permission to
enter the Glebe Land to cut the Cemetery Hedge. She said
she wished her Husband to be present during the cut. It was
agreed to ask Mr A Smith to submit a price for cutting the
inside hedge. A top price of £50 was agreed.
