Minutes of the Winsham Parish Council meeting on Friday, 12th October 1990 held in the Jubilee Hall at 8.00 p.m.

50. Apologies for absence.

51. Minutes.

After additions to Minute 44 and 49, the Minutes of the meeting on 14th September 1990 were signed as a true record.

52. Matters arising.

Fence in the Small Recreation Ground, Footway Light in Davies Close and Trees in Davies Close. These items were dealt with on Agenda No 6 - Hinute No 55.

No reply received to the letter asking for permission to fix a Litter Bin to the Direction Post by the Telephone Kiosk. Mr Trickett will pursue this matter.

Resurfacing of Roads. A letter received from Mr Kirk of the Highways Management Dept states that tidying will be carried out. Mr Woodward and the Clerk met Mr Kirk in Winsham and pointed out several areas needing attention. Maintenance Operatives have been in the Village generally tidying and filling some dangerous patches.

Play Equipment. Mr Slade said his aquaintance will inspect the Igloo tomorrow and tender his price for repairs. Mr Slade will fit replacement parts to the See Saw. A letter of thanks will be sent to Mr K Fowler for his repairs to the swings.

No 3 Western Way and No 10 Bakers Field. Mr Fisher will follow up on this matter.

53. Police.

P.C. Mazzei reported. He said no burglaries had been reported in Winsham. He was told the Traffic Division had been in the Village carrying out a speed check. On the subject of the proposed Weight Restriction at Whatley Lane, the Police would agree with this and the feeling of the meeting was agreement. Mrs Loaring asked for a Police visit to the School and also a visit of a Police Car for the children to see at close hand.

55. Mr L Fisher.

Mr Fisher raised the subject of screp cars being parked in the field at the rear of Ashman's Garage. Mr Gough was given until the end of September to clear the cars. Today, 12th October there are 7 cars in the field. The Council agreed to report this to the District Planning Dept. Mr Fisher also reported an anomaly on the Community Charge. Whereas on the old Rates system Rate Relief could be claimed for noise, such as low flying aircraft, no such claim can be made on the Community Charge. Concerning dogs fouling public places and dogs being a nuisance at the rear of Ashman's Garage. Mr Fisher will pursue this. Also the Parish Council will seek advice from the Environmental Health Officer.
Mrs Rose asked for another wooden 'dog' sign to be erected at the entrance to the Cemetery Path. This will be ordered.
Footway Light in Davies Close and the faulty fence in the Small Recreation Ground. Mr Fisher is meeting Mr Whiting, SSDC Technical Dept on the matter. Trees in Davies Close. This will be chased.

56. Mr J Trickett.

Mr Trickett spoke on the subject of heavy transport in Whatley Lane. He agreed that a Weight Limit should be introduced. Regarding Education. A £4.6m saving is required in Somerset. Definite proposals of how this will be acheived will be made in December. It is fairly certain that school meals will be discontinued in April 1991. If this is the case, packed lunches will be provided for children whose parents are on Income Support. On the proposed alteration to the Direction Sign at Horn Ash. No response received from Dorset County Council.

57. Clerk's Wage.

It was agreed to agree with the recommendation of the N.A.L.C. The wage is £1.10 for each person on the Community Charge Register of the Parish. The number in the Parish of Winsham is 580, making the wage £638.00 per year.

58. National Association of Local Councils.

The N.A.L.C. is appealing for funds and suggest 5% of the Parish Council's budget. No decision was made. The subject will be on the Agenda for a future meeting.

59. Opting out of the N.H.S.

Details of the options will be passed to the Councillors in turn and the whole subject will be discussed at a future meeting.

60. Dogs at the rear of Asnman's Garage and Dogs fouling public places.
