176 Minutes

The Minutes of the previous Meeting, having been circulated, were approved and signed by the Chairman.

177 Matters Arising

Insurance (Ref. Minute 166 (1)). The Clerk reported that the Norwich Union did not appear to be familiar with the requirements of local councils. RESOLVED that the necessary policy should be taken out with Municipal Mutual Insurance Ltd.

178 Notice Board. (Ref. 166(2)). It was reported that the notice board was available, that the Jubilee Hall Management Committee would allow its erection provided that it was modified to conform to the standard design. Mr N. Hebditch agreed to carry out this work.

179 Footpaths. (Ref. Minute 167)

The Clerk reported that the District Council had acknowledged receipt of the survey and indicated that it would take points up with the owners concerned. RESOLVED that the District Council be requested to erect footpath signposts in accordance with the requirements of the Countryside Act 1968. Mr. Barnham reported that 39 signposts were required and 36 waymarks in addition.

180 Burial Fees. (Ref. Minute 168)

In view of the very low income received, it was agreed to leave the question of any increase in abeyance. It was felt that the Cemetery Regulations should be checked and possibly revised. Miss Wren agreed to search old Parish meeting minutes for any records. Maj.Cameron presented a copy of Regulations prepared for his previous parish. Agreed that he, with Miss Wren and the Clerk, should investigate and make recommendations.

1 81 Planning Applications

a) The following decisions had been received:

- i) Approval - Conversion of cottage into two dwellings, Manor Farmhouse.
- ii) Temporary approval - Caravan at rear of Post Office, iii) Approval - Erection of 2 bungalows at Court Street, iv) Approval - Erection of bungalow at Back Street, v) Approval - Construction of Sewage Treatment Works.

b) Applications:

750295 - Erection of dwelling at Cornerstones, Back Street. No objections, subject to reservations on access. 750462 - Erection of conservatory and carport at Greenhay, Bakersfield. No objections.

182 Maintenance

It was noted that the District Council had not yet started any grass cutting. Mr. Barnham suggested the use of sodium chlorate for weedkilling in the cemetery and churchyard, Discussion was deferred to the Annual Parish Meeting.
