### 24. Apologies for absence.

### 25. Minutes.

The Minutes of the meeting held on 9th June 1989 were signed as a true record.

### 26. Matters arising.

Dogs Fouling Signs. Mr Slade will be asked to provide concrete to fix the signs.

Cemetery Hedge. Mr Pym has trimmed the Glebe Land side of the hedge, but when he started on the top he was stopped and ordered out of the field by Mrs McCallum. The meeting decided to ask Mr A Smith for a price for cutting the top of the hedge in October. The hedge to be cut from the inside.

Street Cleansing. Still no reply. Will be chased again, with a copy to Mr L Fisher.

Play Equipment. Repairs to the swing to be completed.
