28. Public Question Time.

Mrs S J Baigent spoke. A Jumble Sale held raised £126 towards the cost of Play Equipment. The next event is a Sponsored Walk on the 24th July. Some plans and a quotation has been received from 'Playdale'. This was passed around the Meeting.

31. Matters arising.

Traffic Calming at Forton. The Clerk was asked to contact Mr Esp to find out if he has any news on this matter.

Street Cleansing. Details received. It was thought ridiculous that 100 mtrs is planned for Fore Street and 200 mtrs for Back Street.

Street Cleaning Survey. This was passed to Mr Woodward to complete.

Pamphlet on Walks. Mr Fowler has seen Mr Smart and they will meet again to discuss the matter.

Year 2000 Project. Nothing was decided.

Street Lighting. The Clerk had met Mr Wardman of the County Council. The position of the two lights was decided and a specification will be forthcoming. It will then be passed to SWEB for a price.

Mrs Rose asked for the Footpath the other side of the Stile at the Cemetery Gate to be cleared. The Clerk will contact the Footpaths Officer.

32. Play Equipment.

The plan provided by 'Paydale' shows the existing Igloo to be removed. Both Mrs Jones and Mrs Rose insist this item stays.
