# 40. Apologies for absence.

Was received from Mr C Baigent (Dist Cllr).

## 41. Public Question Time.

Mr Julian Howell spoke on the Local Neighbourhood Watch. A news leaflet has been produced and will be delivered to every house in the Parish.

Mrs Mary Lewis thanked the Parish Council for having news of Parish Council Meetings printed in the Parish Magazine, especially Mrs J Gowers for writing the details.

# 42. Minutes.

The Minutes of the Meeting on the 8th July 1994 were signed as a true record.

## 43. Matters arising.

STREET LIGHTING. A Quotation received from SWEB for the two Lights in the sum of £554 + VAT. This price does not include the trimming of trees adjacent to the Malt Houses in Court Street.

The Clerk was asked to contact B Powell & Sons for a price to trim the trees.

FOOTPATH IN WESTERN WAY. It was considered the road is too narrow to accommodate a footpath. The road has been marked for repairs. This will be watched when the repairs are carried out.

EXTENDING THE CEMETERY. Mr Speyer will arrange a meeting with Mr Bullivant to discuss the subject. Regarding extending the Cemetery at the bottom end, it is thought the ground will be too stoney. If this is pursued, Mr Peter Parfitt will be asked to dig some trial holes.

WAR MEMORIAL REPAIRS. Prices received from the District Council:
Cleaning down, pressure washing and repointing.
£2080.00 + VAT

Repointing only.
£1100 + VAT

Any Dayworks. £20 per Hour + VAT.

Mrs Rose suggested the cleaning and repairs should be done in 1995 to mark the end of World War 2.

The Clerk had checked on the Street Cleansing Schedule and found that Church Street was not included. He was asked to query this.

## 44. Police.

P.C. Roger Saunders is now our Community Constable. He said he would visit Winsham at least once a day when on duty. He reported a van belonging to Mr Langridge had been stolen. The van was recovered but all the tools were missing. Also that cars were being stolen at Cricket St Thomas. Mr Slade spoke of accidents at at the Cricket St Thomas corner with the A30.

Pemmission Granted by the Development Services Dept.

The Clerk was asked to contact Mr Baigent regarding having a Padlock fitted to the new Litter Bin by the War Memorial.

## 47. Finance.

The Financial Statement was accepted after an alteration. It is considered the finances are quite healthly.

# 48. Mr D Esp.

Traffic Calming at Forton. A Traffic Survey will be carried, shortly. It is considered by the Winsham Councillors that the Forton 'bumps' are not a legal profile. This will be pursued.

Police Partnership. This subject will be discussed at a future Meeting. Regarding the proposed Mirror on the A30. No satisfactory answer has been received.

Mrs Rose spoke about cars, making for Forde Abbey, turning into Pooles Lane. The road sign needs altering.

#### 49. Rose Bush on the Parsons Grave.

It was agreed to allow the Rose Bush but with the condition that if the bush is not kept in check, the Parish Council have the right to remove it. The Clerk was asked to obtain Guide Lines from other Burial Committees. This subject will be on the next Agenda.

#### 50. Name Plate for Winsham.

Mr Esp and Mr Baigent will pursue the legallity of erecting such a sign. If it is allowed, designs will be sought.

#### 51. Barrier outside the School.

Again Mr Esp and Mr Baigent will pursue the legal side of this.

#### 52. Insurance.

It was agreed to renew the Insurance with Zurich Municipal for £135.00p. The Clerk was asked to approach the S.A.L.C. asking if the cover is sufficient.
