Minutes of the Winsham Parish Council Meeting held on the 11th November 1994 in the Jubilee Hall at 8.00 p.m.

70. Apologies for absence.

Were received from Mr D Woodward and the Police.

71. Public Question Time.

Mrs J Smart asked about the Road Sign for Winsham. She was informed this matter was being pursued. She also enquired if any plans by the Parish Council were in hand to organise anything for 1995 - the end of World War 2. She said she would be willing to set up an exhibition in the Jubilee Hall if this would help.

Mrs Rose said the 8th May 1995 would be a Bank Holiday to mark the end of the War.

Mr Slade said the Royal British Legion may be planning something. Mrs Jones said she woold ask at the next Meeting. The subject will be on the next Agenda.

Regarding the Street Fair for 1995. There is some opposition to the proposed theme of 'Hollywood'. Mr Fowler said he proposed the Parish Council should support the decision by the Jubilee Hall Management Committee. This was agreed.

72. Minutes.

The Minutes of the Meeting on the 14th October 1994 were signed as a true record following an alteration to Min. 58.

73. Matters arising.

STREET LIGHTS. The Clerk was asked to place the Order with SWEB asking them to advise of the starting date so that B Powell & Sons can trim the trees.

FLOWER BED IN THE CHURCHYARD. It was suggested a small plaque should be placed in the Flower Bed saying the Parish Council have sponsored the Bed. Permission will be sought from the P.C.C. and a price for the plaque will be obtained by the Clerk.

TOMB IN THE CHURCHYARD. The S.A.L.C. will be contacted by the Clerk in an effort to determine who is responsible for the upkeep of the Tomb.

HIRST & SONS - re: SEE SAW. This Firm is out of business. Mr Fowler will look at possible repairs. He will dismantle the plank as the Inspector considers it dangerous.

HELICOPTERS AT CRICKET ST. THOMAS. A letter from Mr Taylor states that the noise nuisance was a one-off and there are no plans for a repeat.

TANKERS IN WHATLEY LANE. Despite the Parish Council letter asking for the tankers to be rerouted, they are still using the Lane more than is thought necessary. Mr D Esp will be asked to pursue the matter. Also a letter will be sent to the Planning Dept stating that owing to Planning Application No. 942009 it is considered that more triffic will use the lane.

Mrs MARY LOARING RESIGNATION FROM THE PARISH COUNCIL. This was accepted with regret. The flowers had been presented to her and she asked the Clerk to thank the Council.
