Minutes of the Winsham Parish Council Meeting held on Friday, 14th October 1994 in the Jubilee Hall at 8.00 p.m.

56. Apologies for absence.

Received from Mr C Slade, Mr K Fowler, Mrs M Loaring and Mrs J Gowers. Also the Police.

57. Public Question Time.

Miss Baxter spoke of the proposed Street Light at the bottom end of Court Street. She said she and Mr Buller did not want this light. She thought it a waste of money.

58. Minutes.

The Minutes of the Meeting on the 9th September 1994 were signed as a true record after the addition of a suggestion ^{to} Mrs Gowers that a sign should be erected at the top of ~~Fore~~ ^{High} Street warning motorists to slow down.

STREET LIGHTS. Re: Minute No.57. More opinions will be sought from residents living adjacent to the proposed light.

EXTENDING THE CEMETERY. A letter has been sent to R B Taylor & Sons, the Agents of Mr Bullivant, asking if an independant valuation would be acceptable to price the land. The Clerk had spoken to the Valuer by 'phone and was told the land in question is worth more like £1500 than £5000.

Regarding burials in the Churchyard. The Churchyard was closed in 1891.

PADLOCK FITTED TO NEW LITTER BIN. Mr Fowler has fitted the lock but concern was felt that rainwater collects in the bin.

ROSE ON THE PARSON'S GRAVE. The Clerk has contacted Mrs Parsons. She has changed her mind and does not now want a rose.

FLOWER BED IN CHURCHYARD. Mrs Gowers has planted this and it was agreed that she should be reimbursed for any cost.

TOMB IN THE CHURCHYARD. Asthis is classed as a Listed Building steps will be taken to ascertain who is responsible for its upkeep.

WAR MEMORIAL REPAIRS. It was decided to defer this matter until 1995.


A letter from Miss Baxter. This stated much the same as she said in Minute No. 57.
